Attendance referral checklist

This checklist should be completed before submitting an attendance referral. The Ealing Attendance Service will use one of the following interventions to improve attendance: Attendance Contract, Warning letter, Notice to improve letter, Fixed Penalty Notice, Further legal action. We may also work as part of a multi-agency approach.

Please note: For Children Looked After (CLA), in addition to your usual processes, please ensure you are sharing any concerns with: The child's Social Worker, the Carer, the parent if applicable and child's virtual school; the case worker assigned to the child (this may not be Ealing)

We would ask that schools please consider the following:

2. Formalised support, through one or more of these processes: EHAP, School Attendance Contract or an Attendance Support Plan

Support to be considered where applicable:

- ✓ Voluntary early help assessment (EHAP).
- ✓ Monitor the impact of any intervention(s) and make adjustments where necessary in discussion with the pupil, parents and any other partners involved.
- ✓ Signposting or referrals to wider local authority or health services that might support the family (e.g., housing needs, drug, and alcohol support).
- ✓ Signposting or referrals to voluntary and community sector programmes or support (e.g., foodbanks or community support groups).
- ✓ Support and advisory services (e.g., benefit support).
- ✓ Statutory children's social care involvement where there are safeguarding concerns, especially where absence becomes severe (below 50% attendance)
- ✓ Work with other schools in the local area, such as schools previously attended and the schools of any siblings.

- ✓ Formal parenting programmes (e.g., a course with a specified number of sessions)
- Provision of mentoring, careers advice, college placements, 1-2-1 tuition or out of hours learning, or where appropriate an education, health and care plan or alternative provision.
- 3. <u>Considered the impact of mental or physical ill health or their special educational</u> <u>needs and/or disabilities</u>
